Dakota Funds Group, LLC, and Dakota Live!, LLC (“Dakota”, “we”, “our”, or “us”) is providing you notice that your information is contained in the Dakota platform. Dakota Live!, LLC is the controller of the personal data described in this Notice.

We process your business contact information

Dakota collects and distributes business contact information to help companies maintain an up-to-date customer relationship management database. This enables companies to make informed decisions about marketing opportunities for investment strategies.

We collect and distribute your name, professional role, office address, business email address, and business phone number. We collect this information from publicly available sources such as public-facing company websites and public filings.

Purposes for processing business contact information

Dakota processes business contact information for marketing and advertising purposes. This includes organizing and making such information available to display in our products that help companies update their customer relationship management databases. It is possible that viewers of our platform may view your information to make qualitative judgments about you or your company, to offer employment opportunities, to directly market to you, or to reach out to seek partnerships.

Legal basis for processing business contact information

Our legal basis for collecting and sharing your business contact information is Dakota’s legitimate interests in providing a platform to serve investment managers, strategic advisers, and service providers. The platform is used to make informed strategic decisions, improve networking, and source investment and business opportunities. Sometimes, we process this information on the basis of consent.

Recipients of the personal data. Our employees, website visitors, and subscribers may have access to your business contact information on our platform.

Storage of your personal data. We will store your information until (A) you send Dakota a written objection using a contact method prescribed in our Privacy Policy, or (B) Dakota determines that the information is no longer valuable to Dakota’s subscribers, subject to exceptions as discussed in this Notice, our Privacy Policy, or under applicable law, contract, or regulation. For example, Dakota may determine that such information is no longer valuable if it is not of interest to its clients or if the information is no longer accurate.
