



- Current Target: Diversified structure that has performed well since 2021; still effective but needs a new mandate to reduce concentration as fixed income allocation grows.
  - Alternative 1 (Most Aggressive): Adds 11% to a new core mandate and equal-weights Reams and Loomis; highest return potential among options but still less aggressive than the current target.
  - Alternative 2 (Moderate): Adds 19% to a new core mandate with equal weighting to Reams and Loomis; maintains the existing US government index allocation.
  - Alternative 3 (Most Conservative): Boosts the US government index by 5%, adds 14% to a new core mandate, and equal-weights Reams and Loomis; emphasizes liquidity and lower risk.
